The participants were informed that “Punjab Financial Advisory Services (PFAS) Authority” being the Transaction Advisor (TA) evaluated the Financial Bids of technically qualified bidders of three groups i.e. Group – 1, 10 & 11. Group-wise reports were submitted for BOEC. The details are as under;

Group – 10 : Faisalabad – Sumundari – Rajhana (56 km) & FSD Canal Expressway (52km)
Group – 11 : Faisalabad Ring Road (97 km)

4. The financial evaluation is based on the Bidders' proposed First Operational Year Revenue Share and same was approved by Authority. The evaluation formula for Financial Score, as defined in Section 6.5 of the RFP, is as follows:

Financial Score = (Bidder's First Operational Year Revenue Share ÷ Highest First Operational Year Revenue Share among all evaluated Bidders) × 100

The Bidder receiving the highest Financial Score shall be declared the Successful Bidder

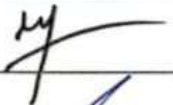
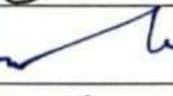
